- USDA announced the February Class III price at \$20.91 per cwt., up 53 cents from January and up \$5.16 from a year ago. The February Class IV price was announced at \$24 per cwt., up 91 cents from January and \$10.25 per cwt. from a year ago. Class III futures prices on the CME average \$23.20 per cwt. for the remainder of the year, while Class IV futures prices average \$24.40 per cwt.
- USDA's Dairy Products Report shows total cheese output (excluding cottage cheese) at 1.17 billion pounds in January, up 2.8 percent from a 1.8 percent from a month ago. American cheese ago and up production was up 1.1 percent from a year ago, while Italian-type cheese production was 1.7 percent from a year ago. Total butter production was at 195 million pounds, down 6.9 percent from January 2021 but up 8.5 percent above December 2021. Nonfat milk production was down 13.8 percent, while skim milk powder was up 20.6 percent.
- Australian milk production was down 6.3 percent to 714 million liters in January. For the season, which started in July, the Oceania state was below the prior season by 2.6 percent.

Government and Industry:

- USDA is seeking comments on nutritional standards for milk served in schools. This follows transitional guidance which continued current rules until a new policy can be adopted. USDA says that it will be based on Dietary Guidelines for Americans 2020-2025. Those interested in providing comments related to the value of fuller fat milks in schools can provide comments to the USDA. Comments are due March 24 to the USDA Food & Nutrition Service. Comments re the value of whole milk may be directed to Tina Namian, Chief, School Programs Branch, FNS, 1320 Braddock Place, Alexandria, VA 22314. Refer to FNS-2020-0038-2936. - USDA has extended the deadline to sign up for the Dairy Margin Coverage Program until March 25 to allow dairy farmers time to visit their local FSA Office to sign up for the Dairy Margin Coverage Program in 2022. DMC should be looked at as an insurance policy that sets a milk price floor, not whether it is projected to provide a benefit. Based on the USDA's online DMC Decision Tool, the DMC feed cost is expected to average \$11.74 per cwt in 2022. If a dairy farmer elects the maximum \$9.50 per cwt margin coverage for 15 cents per cwt., that sets a U.S. all-milk price floor of \$21.24 for up to 5 million pounds of production history. Dairy producers should consider visiting their local FSA office to enroll in the program.
- With dairy futures markets showing strength right now, especially in Class IV futures prices, right now may be a good time to consider using the Dairy Revenue Protection Program to protect your profits for the coming year. Dairy RP offers market-based price coverage for the next five quarters, which currently includes the second quarter of 2022 through the second quarter of 2023. The program allows you to put a floor under your milk price. To learn more, contact your crop insurance agent.
